### Urbanization and Industrialization: The interfering influence on insects, public health and environment

Humans alone have the potential to gather resources from beyond their immediate surroundings and process them into different and more versatile forms. This has made humans to thrive and flourish beyond natural constraints. Primitive humans used natural resources to satisfy their basic needs of air, water, food and shelter. These natural and unprocessed resources were readily available in the biosphere, and the residues produced by

the use of these resources were generally compatible with or easily assimilated by the environment.

Improvement over the traditional practice in terms of the various activities by man have led to urbanization and industrialization which produces anthropogenic (man-induced) pollutants that overloaded the system, and interferes with the well being of flora and fauna. The resultant effects of this is the distortion of natural equilibrium of the ecosystems in terms of emergence of different kinds of pests and disease causing organism, resurgence of pests and diseases of public health interest and climate change.

With the dawn of the industrial revolution, humans were better able than ever to satisfy their needs for air, water, food and shelter. So, humans turned their attention to other needs beyond those associated with survival. The industrial production, distribution and use of different forms of products usually results in more complex residuals and/or wastes, many of which are not compatible with or readily assimilated by the environment. As the acquired needs (or luxuries) increase so will the complexity of the production chain, and mass and complexity of the pollutants generated.

Urbanization entails development of infrastructures such as housing, good roads, parks, dams and a host of others that alters the natural environmental factors and result to negative impact on the health of the residents. The physical and chemical properties of particulates are associated with health risks such as respiratory problems, skin irritations, eyes inflammations, blood clotting and various types of allergies.

In addition, the impact of mankind on biodiversity has clearly been detrimental to many fauna (insect and other arthropods) and human health, but the story is more complex and subtle than has been appreciated. Urbanization provides ready-made laboratories for studying evolution and adaptive processes, and examining the influence of humans on flora and fauna creates the potential to mitigate any negative effects. Entomologists should be more positive about our relationship with the natural world: We should celebrate the creative aspects of our impact on insects and other arthropods in addition to concerning ourselves with the negative effects by proffering empirical researches that can produce results which will be adopted to mitigate problems caused by urbanization and industrialization.

Of note is the fact that, it is not all bad news as many animal (insect and other arthropods) and plant species have adapted to the new stresses, food sources, predators and threats in urban and suburban environments, where they thrive in close proximity to humans. Their success provides researchers with valuable and sometimes unexpected insights into evolutionary and selective processes.

This conference marks the 49th anniversary of the Society which precedes the golden jubilee celebration in Lagos next year. The tenure of one term of two years in office for some executive members of the Society you elected in October 2012 in Benin, will expire before the close of this conference. Consequently, there will be an election for the posts of President, Vice President, Secretary, Asst. Secretary/PRO and Treasurer. We thank you immensely for your cooperation and understanding.

### Golden Jubilee Celebration of ESN, October 2015

A proposal, considered and approved by Council, has been made for the Golden jubilee celebration of our Society in 2015. It will be recalled that in my 2013 Presidential address gave a chronology of the Foundation of ESN.

Entomologically speaking, our highly esteemed professional Society (ESN), with the broad objective to "further the study of insects in Nigeria" started with the "egg-phase" in a holo /hemimetabolic setting in October 1965. Its inaugural meeting was held in the Department of Zoology at the University of Ibadan (Balogun, 1995 Presidential address). It is on record that one Dr A.D, Pickott, Head of International Capsid Research Team, Cocoa Research Institute, Ghana delivered an inaugural address titled "the Ecological Approach to the Solution of Pest Problems in Agriculture".

**Distribution:** This species is widespread in central and southern Europe, temperate Asia, Africa, Australia and Oceania, and has also recently been confirmed to have successfully invaded Brazil. It is a migrant species, able to reach Scandinavia and other northern territories. bordered straw in the UK, where it is an immigrant) is a moth, the larvae of which feed on a wide range of plants, including many important cultivated crops. It is a major pest in cotton and one of the most polyphagous and cosmopolitanpest species. It should not be confused with the similarly named, related species *Helicoverpa zea*.

### Life History

THE EGGS are spherical, 0.4 to 0.6 mm in diameter and have a costate surface. They are white, later becoming greenish.

THE LARVAE takes 13 to 22 days to develop, reaching up to 40 mm long in the sixth instar. Their colouring is variable but mostly greenish and yellow to red-brown. The head is yellow with several spots. Three dark

stripes extend along the dorsal side and one yellow light stripe is situated under the spiracles on the lateral side. The ventral parts of the larvae are pale. They are rather aggressive, occasionally carnivorous and may even cannibalise each other. If disturbed, they fall from the plant and curl up on the ground.

THE PUPAE develop inside a silken cocoon over 10 to 15 days in soil at a depth of 410 centimetres (1.63.9 in), or in cotton bolls or maize ears.

THE ADULT moth body length varies between 12 millimetres (0.47 in) and 20 millimetres (0.79 in) with a wingspan of 3040 millimetres (1.21.6 in). The forewings are yellowish to orange in females and greenish-gray in males, with a slightly darker transversal band in the distal third. The external transversal and submarginal lines and the reniform spot are diffused. The hind wings

are a pale yellow with a narrow brown band at the external edge and a dark round spot in the middle. It takes about 30days from egg to adulthood.

Economic importance: The greatest damage is caused to cotton, tomatoes, maize, chick peas,sorghum,millet,wheat/ba rley, alfalfa, soy beans, okra, garden eggs, sorrel/roselle, pepper, sunflower and tobacco. The economic threshold of harmfulness in central Asia is three to five larvae per hundred plants of long-staple cotton and eight to 12 larvae per hundred plants on medium-staple cotton. In cotton crops, blooms that have been attacked may open prematurely and stay fruitless. When the bolls are damaged, some will fall off and others

will fail to produce lint or produce lint of an inferior quality. Secondary infections by fungi and bacteria are common and may lead to rotting of fruits. Injury to the growing tips of plants may disturb their development, maturity may be delayed and the fruits may be dropped.

Host plants: H.armigerais a highly polyphagous species. The most important crop hosts are tomato, cotton, pigeon pea, chickpea, sorghum and cowpea. Other hosts include groundnut, okra, peas, field beans, cowpea, soybeans, lucerne, Phaseolus spp., other Leguminosae, tobacco, potatoes, maize, flax, Dianthus, Rosa, Pelargonium, Chrysanthemum, Lavandulaangustifolia, a number of fruit trees, forest trees and a range of vegetable crops. In Russia and adjacent countries, the larvae populate more than 120 plant species, favouring Solanum, Datura, Hyoscyamus, Atriplexand Amaranthusgenera. H. armigeraH. Armigera

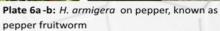

### BENEFICIAL IMPORTANCE OF H. armigera

The adult moth is a pollinator of flowers/ornamental and crop plants, while the larvae can be a pest on same plants or other crop plants after laying its eggs and hatched to larval stage which is the most destructive stage.

to abortion of flowers and the larvae feeds on the developing grains and the faeces in addition causes qualitative damage with combination of puncturing the seeds which eventually makes the grain unfit for human consumption and devaluing the market prize as shown in Plates 1-4. Similar damage is caused on tomatoes and peppers, which makes the fruits unattractive and unfit for human consumptionand open entries for secondary infections by bacteria and fungi, Plates 5&6. The African bollworm feeds on leaves, flowers and pods of okra. The main damage occurs on flowers and pods. Attack on flowers results in flower abortion. The caterpillar usually bore clean, circular holes in pods, causing extensive damage and promoting decay from secondary infection by diseases (Plate 9). Similarly on pulses and oil seeds, the flower and buds and pods are bored by the larvae, which i). Regular weeding to remove

> eventually leads to premature shedding of flowers and pod drop. The pulses also becomes unfit for human consumption (Plates 8, 10, 11, 14 &15).H. armigera attack it's host plants fruiting bodies, which opens up wounds for secondary infections by pathogenic organisms causing severe disease damage on most Malvaceas family most especially sorrel/roselle and kenaf;Salaneceous crops such as garden eggs etc.

### MANAGEMENT AND CONTROLMEASURES

At the early rains, H. armigera move to sprouting ratoon cotton, weeds, thrash and debris and survive also Okra, roselle, Kenaf, maize, sorghumetc which usually matures earlier than cotton one of its major host plant. They will feed on them, multiply until cotton delayed and the fruits may be dropped bolls starts forming then they will



migrate to cotton. Therefore, management and control of H. armigeracould be divided into three sub-topics: cultural, insecticidal, biological and integrating any of the three has been successful especially in Americas and developed countries in Agriculture.

a). Cultural measures include:

alternative hosts and shelter for pest or otherwise clean farm sanitation.

ii). A rotation of different crops should be used on soils previously used for growing host plants. This is to reduce the effects of soils pests by breaking their reproductive cycle. Plants should be uprooted and destroyed or ploughed under the soil after harvesting.

iii).A 'closed season' should be operated that is when sowing of a new crop is delayed for at least two months after the harvest of the previous crop.

iv). Synchronizing planting dates within one area. Crops such as okra, pepper which are also preferred hosts of pests, should only be planted at the same time. When this is applied in conjunction with the closed season, it will break the pest life cycle.

v). Manipulation of planting dates reduces cotton pests.

vi). Deep and early ploughing of cotton field, which was previously used for cotton, exposes the larvae, soil pests to desiccation and predators.

vii). Inspect plants regularly; once or twice a week after plants begins to bloom. Early detection of eggs and/or caterpillars before they bore into the pods is important.

viii).Hand pick and destroy eggs and caterpillars. This helps when their numbers are low and in small fields.

### b). Insecticides.

i)Polythrin C (Cypermthrine + Profenofos 16 g + 150 g/l) and

Sherpa plus (Cypermethrine + Dimethoate 12g + 100g/l) has been effective.

ii). Sherpa plus (cypermethrine 12g + dimethoate 100g/l) was very effective particularly on most insect pests especially on cereals and malvaceous plants.

iii). Spraying with quinalphos 25 EC (2 ml/litre of water) or carbaryl (4 g/litre of water) or carbaryl 50WP 2 g/lit or profenophos 0.05 per cent effectively controls the pest. Before spraying all the affected plant parts should be removed.

### **BIOLOGICAL CONTROL**

i. Conserve natural enemies. The African bollworm has a wide variety of natural enemies. Parasitic wasps and predators such as ants, lacewings, assassin bugs (Figure 2 below) and ladybird beetles are important in natural control of this pest which has been successful.

ii. Mixtures of bioagents such as vivux(applied as nuclear polyhedrosis virus (HaNPV) @250-500 larval equivalent/ha), dipel, xentari, Bacillus thuringiensisvar. kurstaki 2 g/lit.Collect and destroy the infected fruits and grown up larvae. Do not spray insecticides after maturity of fruits. Spray with botanicals or neem extracts has been successful with good spray coverage and targeting small caterpillars before they bore into the flowers, bolls and pods is very important (Figures 1 & 3below).http://www.infonhttp://ww . infonet iovision.org/res/res/files/1530.280x 185.clip.jpeget-biovisio

### THE VISITORS OF THE DEAD: THE ROLE OF ENTOMOLOGY IN FORENSIC PRACTICE

Forensic Scientist uses in forensic investigation. This contribution of entomology to forensic science is Forensic Entomology which should work in cooperation with others especially in the greater part of the world where newer methods such as the use of DNA for human identification are either not available or are still far too expensive for general application.

During the Annual Conference of the Entomology Society of Nigeria tagged ABUJA 2014, a comment by Professor Samuel Asala, representing the Vice Chancellor, brought to light the generally unrecognised relationship between entomology and forensic medicine. For example, careful insect data analysis can assist in forensic investigations such as the determination of time since death (post-mortem index) and site of crime. At a subsequent College of Health Sciences lecture titled "Dead Bones Speak Too: The Role of Bones in Human Identification", Professor Asala alluded to the fact that forensic practice is in a rudimentary stage in Nigeria. He encouraged scientists and practitioners in different areas of the discipline (Pathology, Biological Anthropology, Pharmacology, Law, Chemistry/Biochemistry, Entomology etc.) to come together to enhance forensic practice and interdisciplinary research in Nigeria.

population can also be blamed for the deterioration of the environment. More number of people indicates increased demand for food, clothing and shelter. This demand is leading to deforestation for the purpose of industrialization and urbanization which in turn is affecting the ecological balance. Many people might feel that urbanization and industrialization is the need of the hour, and can't be stopped but it needs to be reduced because the effects of over generation.

### ASPECTS OF ENTREPRENEURSHIP IN ENTOMOLOGY

The green areas of investment in entomology begging for attention in Nigeria include:

i. Entomophagy (rearing of edible insects):

ii. Mulberry sericulture;

iii. Apiculture;

iv. Maggot Production and; v. Pest control and Fumigation

#### Entomophagy

Entomophagy is simply defined as the consumption of insects as food by man. It is sometimes referred to as mini-livestock which has become an emerging ecological concept in animal husbandry. The prospects of edible insects (e.g. African Silkworm, Anaphe venata) to the national food security as food and feed cannot be overemphasized. Promoting edible insects as alternative candidate to conventional production of meat may mitigate crises such as land pressure, deforestation and environmental degradation. About 1900 species of insects are eating worldwide, mainly in developing countries. In Africa, especially in Nigeria, over 470 insects are eating. The insects mostly eaten in the continent are dominated by the orders Lepidoptera, Orthoptera and Coleoptera. These edible insects constitute high quality food for humans, livestock, poultry and fish. Since insects are cold blooded, they have a high quality food conversion rate than conventional livestock and emit less green house gases. However, edible insects are important alternative for other animal based protein sources either for direct human consumption, or indirectly as feedstock. They also provide environmental friendly source of dietary protein because they produce much lower amounts of ammonia than conventional livestock. Eating nutritious insects could help fight obesity, reduce protein deficiency and end national hunger. The roles of entomologists in this business involves rearing edible insects for food and feed, identification and differentiation of edible species, studying biology of edible insects, sexing of edible insects and; mass rearing of edible insects.

### Mulberry sericulture

Mulberry sericulture is the rearing of insect called silkworms on mulberry plant to produce silk. This method of silk production is found in the temperate countries but with the advancement in research, it is

now possible to grow different species of mulberry in different agro-ecological zones of the tropical countries thereby making mulberry sericulture possible in Nigeria. In mulberry sericulture, farmer produces mulberry leaf and sells both the leaf and the eggs of cotton silkworm (Bombyx mori) to the cocoon producer. The eggs hatch into larvae which are fed with the mulberry leaf. The cocoon is then sold to the final producer to produce yarn which could be exported directly or reeled to produce silk. The most interesting thing in mulberry sericulture is that, at every stage of the production, chain employment opportunities and incomes are generated. In addition to silk production, the cotton silkworm insects are also edible, hence serving dual purposes.

#### Apiculture

Apiculture is defined as the artificial rearing and management of honey bee for commercial production of honey and other products of the beehive. Bees may travel as far as 55,000 miles and visit more than two million flowers to gather enough nectar to make just a pound of honey. Honey bee produces up to six different products of lucrative potentials and high demand (in the market) in a range of industries from food processing to medicine. These products are honey, bee wax, propolis (bee glue), pollen, royal jelly (bee's milk) and honey bee venom (apitoxin). It is interesting to know that a litre of pure honey now goes for between N1000 to N2000. In the recent time, pollination service is gaining ground especially in the western world where farmers are demanding for bumpy harvest. Pollination service involves location of bee hives within orchards, plantation and farms and the bee activities are monitored by an expert (beekeeper) especially entomologist. However, during flowering, the expert releases bees to the farmer's field to encourage pollination which brings about higher yield and the beekeeper are paid in return.

#### **Maggot Production**

Maggot production as a business, deals with the breeding of maggot. A maggot is the larva of a fly (order Diptera); it is applied in particular to the larvae of Brachyceran flies such as houseflies, cheese flies and blowflies rather than larvae of the Numatocera such as mosquitoes and crane flies. Maggot farming is a viable and profitable business as it has several uses such as feed for fish and poultry, bait for fishes, therapy for treating small wound, and estimation of time elapsed since death

among others.

### Pest control and Fumigation

Pest control and fumigation is the act of controlling and eradicating harmful insect/pests in our surroundings using chemicals and machines. The importance of pest control and fumigation in our environment cannot be overemphasized. Pest and insects are deadly and can cause severe harm to humans and properties. Most sickness today is as a result of deadly pest/insects that inhabits our environment. Mosquitoes, cockroaches, snakes, rats, termites, bedbugs, tick etc are very harmful and could cause severe damage to our health and properties if they are not controlled. Therefore, it is recommended that our environment should be fumigated once in every three months in order to get rid of these deadly pests. In the past, farmers and agricultural fumigators relied on the use of gases such methyl bromide as fumigant for controlling insects and diseases affecting harvested crop. But these products have broad spectrum effect and as a result pose numerous environmental and health hazards. For instance, methyl bromide which was used primarily for soil fumigation and as a fumigant in the control of insects, nematodes, pathogens, and rodents and weeds is being phased out due to its high ozone-depletion potential. However, carbon dioxide (CO<sub>2</sub>) and nitrogen (N<sub>2</sub>), which are natural products, have been found incredibly effective against pest and insect infestation in dry ingredients.

or most people, old and young, and particularly latter, the insects/arthropods cannot be anything but unwanted friends who often complicate their lives by causing physical harm to their skin and leading to illnesses such malaria. For adults who are more enlightened, they may appreciate the benefits that insects can bring to man. For example, insects pollinate flowers and give rise to the development of fruits such as pawpaw. However, when insects visit man after death, it is for good. They assist the dead body to decompose particularly when the body is lying free on the surface of the earth where decomposition would have normally taken much longer to occur. But beyond that, the visit of insects to a dead body can become a useful tool in Forensic practice. The type of insects that visit the body and the order in which they do so, the time it takes them to dissert the body can assist the forensic practitioner to estimate time since death. Time since death is one of the parameters that the

### COMMUNIQUE OF THE 45<sup>™</sup> ANNUAL CONFERENCE OF ENTOMOLOGICAL SOCIETY OF NIGERIA HELD AT UNIVERSITY OF ABUJA FROM 7-10 OCTOBER, 2014

The 45<sup>th</sup> Annual Conference of the Entomological Society of Nigeria held at Faculty of Veterinary Medicine, University of Abuja, Abuja FCT on the theme "Insect Resurgence: Implication for Agriculture, Health and Sustainable Environment.

Keynote address on the theme was given by Professor Hayward Babale Mafuyai, the Vice-Chancellor, University of Jos after the Conference was declared open by Professor M. U. Adikwu, the Vice Chancellor, University of Abuja. The Conference also attracted other dignitaries such as the Minister of National Planning – Dr. Abubakar Olanrewaju Suleiman; Dr. Chioma Amajo – Chief Executive Officer, Community Vision Initiative and Alhaji Abubakar Haruna Tanko – the Conservator General, Nigeria National Park.

Two hundred and forty (240) participants from within and outside the country including scientists from the Academia, Research Institutes and industries attended the conference in which a total of 173 scientific papers were delivered.

### Three symposia papers were presented namely:

- a. Integrated Vector Management: The Strategy for Vector Control in Public Health
- b. An Emerging Trend for Insect Pest Management in Nigeria
- c. The Role of Insects in Heritability Conservation in the Nigeria National Park

### The Conference highlighted the following challenges:

- i. Insecticide usage treadmill birthed by indiscriminate, non judicious usage of pesticides with consequent adverse impact on non-target beneficial organisms.
- ii. Weak pedestal to grow synergy of management of pests of agricultural and public health importance.
- iii. Inadequate funding of research on the management of pests of agricultural and public health importance.

### The following resolutions were reached at the end of the deliberations:

- Pest resurgence is a complex phenomenon and there is paucity of coherent database from
  which researchers can draw because most research work published in this area in which
  the phenomenon is embedded deals with other aspects such as pest control, ecology and
  insect-plant interactions. Consequently, scientists should be encouraged to carry out
  studies relating insect resurgence to population ecology and thus, allowing resurgence to
  be viewed within a broader ecological context.
- Pest resurgence has been noticed both in the agricultural and health sectors.
   Therefore, there is a need for concerted efforts by entomologists and related disciplines and Government agencies in funding collaborative studies to abate this problem.
- 3. The Nigerian Agricultural production system is characterized by small holder farmers, insect pest resurgence, weeds, diseases, low yields and poor storage systems. It was resolved that biotechnology is capable of improving Nigeria's sustainable agricultural production system by ensuring high yields and reduction in post-harvest losses. It is also capable of dealing with resistance and resurgence of notorious public health insect pests such as mosquitoes, bed bugs, blackflies etc.
- Government should consciously fund Entomological research in both agriculture and health sectors in order to foster the Transformation Agenda of the Federal Government for its citizenry.
- 5. Government should legislate on the proper use of pesticides on food crops, animals and environment; determine safety levels and publicize the hazards resulting from over use and abuse. Entomological Society of Nigeria and the Institute of Entomology should play a key role in setting the standards for pesticide handling, application and registration of pest control practitioners.
